This is why this postgraduate course aims to create professional figures such as consultants and experts who support an effort of internationalisation and managerial innovation, particularly of small and medium businesses



THE PROFESSIONAL PROFILE

A General Counsel

- she/he supports business strategic activity
- she/he is the interface between the firm and several stakeholders, such as public authorities, professionals, providers, clients, etc.

A General Counsel
is capable of:

- undergirding processes of business internationalisation;
- understanding the legal gist of different kinds of business by contributing to teamwork with experts in different sectors
- employing and enhancing managerial innovation, company staff management in a transnational environment, risk-management of IT evolution and cybernetic
- handling legal issues regarding privacy regulation, intellectual property, market competition, logistics and international transport networks, international contracts, management of touristic and environmental heritage



THE ROUTE TO GRADUATION/ I

- It is a two-year course with no more than 12 modules, including one of your own choice
- Modules are comprehensive and compact. Professors are not allowed to fragment them into sub-modules
- All the modules are highly specialistic and they are taught with innovative methods, such as problem-based learning techniques
- Our staff is complemented by external experts in some modules which have been designed in a strongly professionalizing way



THE ROUTE TO GRADUATION/2



- Professionalising seminars and workshops in which students engage with protagonists of business internationalisation and real-life case studies are an important part of the curriculum
- Every module is taught in English as well to let students learn the appropriate professional language and jargon
- We encourage a significant attendance of international students
- Stages and training workshops complement students' education and training
- The final dissertation can be either the outcome of a stage in a company, firm or institution or a case study

We seek a continuous dialogue with stakeholders and social actors representative of local, national, and international economic reality

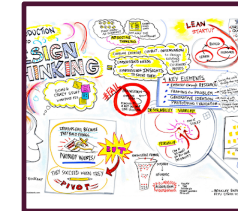

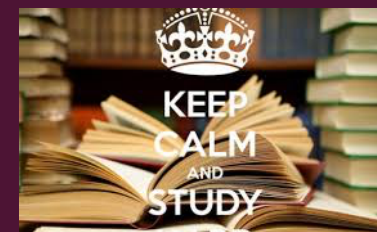

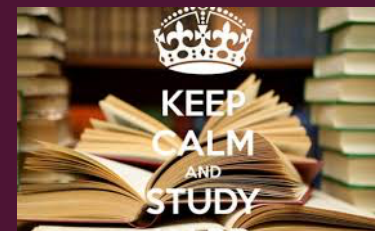
